

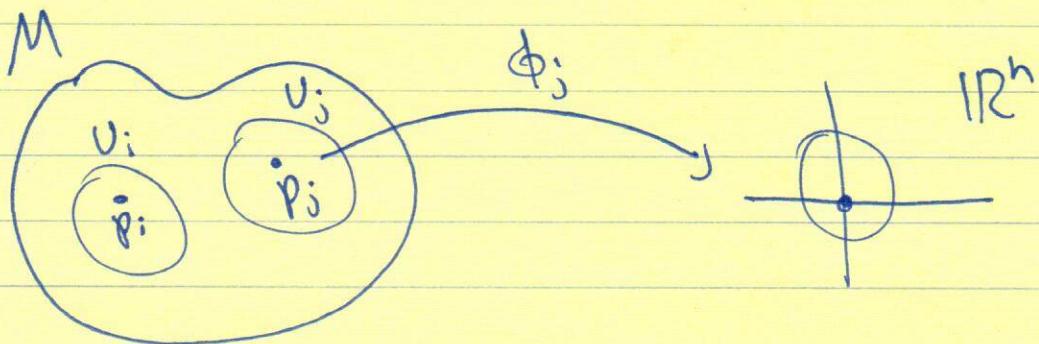

## A. Real manifolds

A (real)  $n$ -dimensional manifold  $M$  is a space that looks locally like  $\mathbb{R}^n$  around each point.



Local coordinates  $\phi_i : U_i \rightarrow \mathbb{R}^n$

The transition functions at the intersections

$U_i \cap U_j$ :

$$\phi_{ij} \equiv \phi_i \circ \phi_j^{-1} : \mathbb{R}^n \rightarrow \mathbb{R}^n$$

are required to be infinitely differentiable,  
i.e. ~~if~~  $\phi_{ij}$  are  $C^\infty$  functions.

The pair  $(U_i, \phi_i)$  is called a chart.

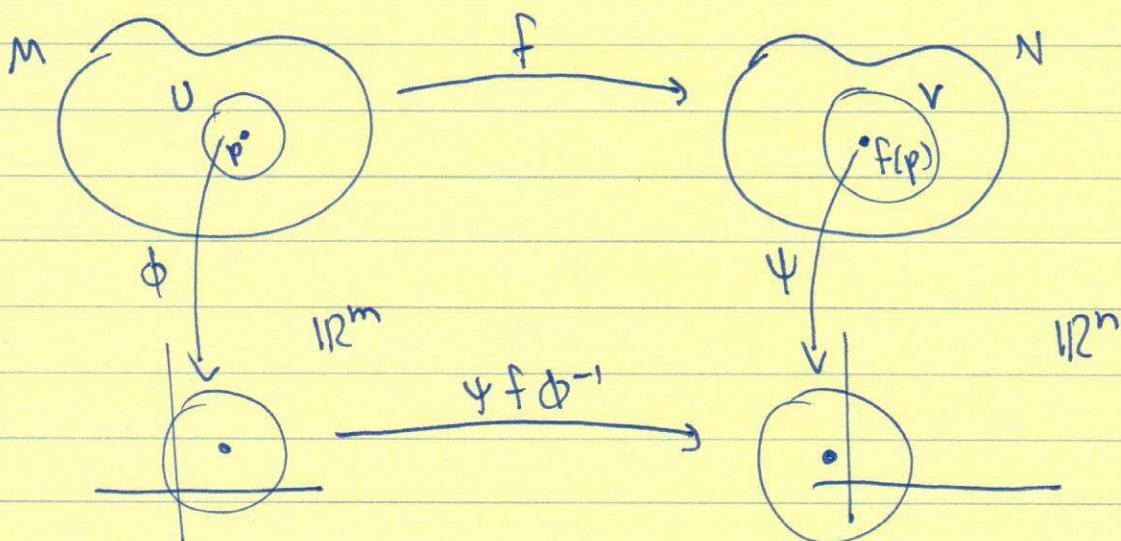
- Differentiable maps

Let  $M$  be an  $m$ -dim. manifold with chart  $(U, \phi)$

Let  $N$  " "  $n$ -dim. " " " "  $(V, \psi)$

A map  $f: M \rightarrow N$  is differentiable if the map

$$\psi f \phi^{-1}: \mathbb{R}^m \rightarrow \mathbb{R}^n \text{ is } C^\infty$$



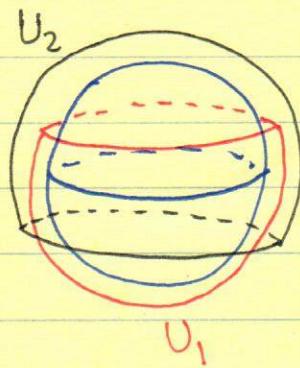
If  $\psi f \phi^{-1}$  is ~~not~~ invertible, and both  $y = \psi f \phi^{-1}(x)$  and  $x = \phi^{-1} \psi^{-1}(y)$  are  $C^\infty$ , the  $f$  is a diffeomorphism.

Diffeomorphic manifolds are regarded as the same manifold (in particular  $\dim M = \dim N$ ).

## Examples:

(1)  $\underline{S^2}$

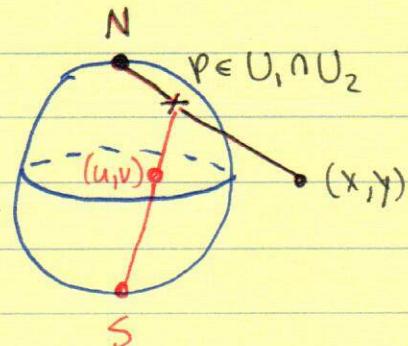
For the two sphere we need only two open sets  $U_1, U_2$ , covering the southern and northern hemispheres, respectively:



Choose stereographic local coordinates

$$\phi_1: U_1 \rightarrow \mathbb{H}^2(u, v)$$

$$\phi_2: U_2 \rightarrow \mathbb{H}^2(x, y)$$



Then the transition function is given by

$$\phi_{12}(x, y) = \left( \frac{x}{x^2+y^2}, -\frac{y}{x^2+y^2} \right)$$

## (2) Lie groups

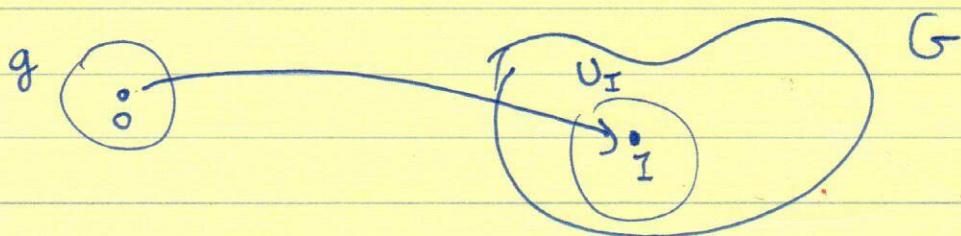
Lie groups are also endowed with the structure of a manifold.

Let  $G$  be a Lie group  $(U(n), O(n), GL(n, \mathbb{R}), \dots)$

and  $\mathfrak{g}$  be the associated Lie algebra, i.e.

a set of linear matrices that generate  $G$ .

This means that  $e^g : \mathfrak{g} \rightarrow G$  is a diffeomorphism from a neighborhood of the origin in  $\mathfrak{g}$  to a neighborhood of  $I$  in  $G$ :



This defines a local coord. system near  $I \in G$ .

We can define a local coord. near any  $g_0 \in G$  by  $g_0 e^g$ .

The transition functions are therefore given by left-multiplication in the group.

- Tangent and cotangent space

We need a more general definition of vectors on general manifolds.

Def. The tangent space to a manifold  $M$

at a point  $P \in M$ ,  $T_p(M)$ , is the collection of all directional derivatives at  $P$  along any curve that goes through  $P$ .

In terms of local coords.  $x^i$ , any element can be expressed as  $v^i \frac{\partial}{\partial x^i} \in T_p(M)$

$\left\{ \frac{\partial}{\partial x^i} \right\}$  forms a basis for  $T_p(M)$ .

A collection of directional derivatives at each point in  $M$  with smoothly varying coefficients  $V^i(x)$  is called a vector field.

The cotangent space,  $T_p^*(M)$ , is just the dual vector space to the tangent space  $T_p(M)$ .

The basis elements of  $T_p^*(M)$  in the local coords.  $x^i$  are the differential line elements  $dx^i$ .

The inner product is  $dx^j \left( \frac{\partial}{\partial x^i} \right) = \left\langle \frac{\partial}{\partial x^i}, dx^j \right\rangle = \delta^j_i$ ;

Let  $V \in T_p(M)$  and  $U \in T_p^*(M)$

$$V = v^i \frac{\partial}{\partial x^i} \quad U = u_i dx^i$$

The invariance of  $V, U$  under coord. trans.

$x \rightarrow x'(x)$  implies the trans. properties of the components:

$$v'^i = v^j \frac{\partial x'^i}{\partial x^j} \quad \text{"contravariant"}$$

$$u'_i = u_j \frac{\partial x^j}{\partial x'^i} \quad \text{"covariant"}$$

Of course the inner product is invariant:

$$\langle V, U \rangle = v^i u_i = v'^i u'_i$$

More generally, an element  $W$  of

$$\underbrace{T_p(M) \otimes \cdots \otimes T_p(M)}_k \otimes \underbrace{T_p^*(M) \otimes \cdots \otimes T_p^*(M)}_l$$

is called a tensor of type  $(k, l)$ , and

can be expanded in the basis of local coords. as:

$$W_{(k)}^{(l)} = W_{j_1 \dots j_k}^{i_1 \dots i_l} \frac{\partial}{\partial x^{i_1}} \otimes \cdots \otimes \frac{\partial}{\partial x^{i_l}} \otimes dx^{j_1} \otimes \cdots \otimes dx^{j_k}$$

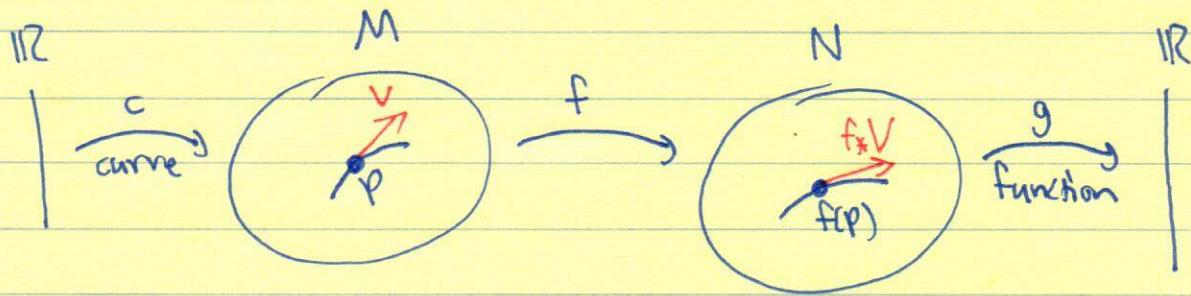
- Induced maps

Let's say we have a map between  
two manifolds  $f: M \rightarrow N$ .

How do vector fields, and more  
generally tensor fields map?

- Vectors map by push-forward

$$f_* : T_p M \rightarrow T_{f(p)} N$$



Let  $V \in T_p(M) \Rightarrow V$  acts on  $gf$  to give a number  $V[gf]$ .

Define  $f_*V \in T_{f(p)}(N)$  by  $f_*V[g] = V[gf]$ .

In local coords.  $V = V^i \frac{\partial}{\partial x^i}$ ,  $f_*V = W^j \frac{\partial}{\partial y^j}$

Take  $g = y^j$ , then  $w^j = V^i \frac{\partial y^j}{\partial x^i}$ .

- Dual-vectors map by pull-back  $f^* : T_{f(p)}^* N \rightarrow T_p^* M$

Let  $V \in T_p M$  and  $\omega \in T_{f(p)}^* N$

Define the pull-back of  $\omega$  by  $f^*$  by:  $\langle V, f^*\omega \rangle = \langle f_*V, \omega \rangle$

Then in local coords:  $\omega = \omega_j dy^j$ ,  $f^*\omega = \xi_i dx^i \in T_p^* M$

where  $\xi_i = \omega_j \frac{\partial y^j}{\partial x^i}$ .

## B. Differential forms

A  $k$ -form is a totally antisymmetric element of

$$T_p^*(M) \otimes T_p^*(M) \otimes \cdots \otimes T_p^*(M)$$

$\brace{ \quad \quad \quad }_{k \text{ times}}$

So a 1-form is just a dual vector  $\in T_p^*(M)$ ,  
which is a differential line element  $w_i dx^i$ .

Local coord. expressions for  $k$ -forms are obtained  
using the wedge product, e.g.

$$dx \wedge dy = \frac{1}{2}(dx \otimes dy - dy \otimes dx) \quad \text{2-form}$$

(= -dy \wedge dx)

$$\Rightarrow dx \wedge dx = 0$$

So a  $k$ -form in local coords.  $x^1, \dots, x^k$  is  
given by:

$$\omega^{(k)} = w_{i_1 \dots i_k} dx^{i_1} \wedge dx^{i_2} \wedge \dots \wedge dx^{i_k}$$

Only the totally antisymm. part of  $w_{i_1 \dots i_k}$  contributes.

•  $\Lambda^p(x) = \text{set of } p\text{-forms at } x \in M$

This is a vector space of dimension  $\binom{n}{p} = \frac{n!}{p!(n-p)!}$

Note that  $\dim(\Lambda^p) = \dim(\Lambda^{n-p})$ , and that

$\Lambda^p = \emptyset$  for  $p > n$ .

The set of all diff. forms on  $M$  is denoted:

$$\Lambda^* = \Lambda^0 \oplus \Lambda^1 \oplus \dots \oplus \Lambda^n$$

This is closed under the wedge operation  $\wedge$ ,

and so defines a graded algebra called  
Cartan's exterior algebra of diff. forms:

If  $\alpha_p \in \Lambda^p$  and  $\beta_q \in \Lambda^q$ , then

$$\alpha_p \wedge \beta_q = (-1)^{pq} \beta_q \wedge \alpha_p.$$

Odd forms anti-commute, and in particular  $\alpha_1 \wedge \alpha_1 = 0$ .

- Exterior derivative

$C^\infty(\Lambda^p) = \text{set of smooth (only differentiable) } p\text{-forms}$

$$f_{i_1 \dots i_p}(x) dx^{i_1} \wedge \dots \wedge dx^{i_p}$$

The "top form"  $\in C^\infty(\Lambda^n)$  is representable by

a single function times the volume element:

$$f(x) dx^1 \wedge dx^2 \wedge \dots \wedge dx^n$$

The exterior derivative  $d$  maps  $C^\infty(\Lambda^p) \rightarrow C^\infty(\Lambda^{p+1})$   
as follows:

$$\omega_p = f_{i_1 \dots i_p}(x) dx^{i_1} \wedge \dots \wedge dx^{i_p} \in C^\infty(\Lambda^p)$$

$$d\omega_p = \frac{\partial f_{i_1 \dots i_p}(x)}{\partial x^i} dx^i \wedge dx^{i_1} \wedge \dots \wedge dx^{i_p} \in C^\infty(\Lambda^{p+1})$$

Only the totally antisymmetric parts of the partial derivatives contribute.

In particular  $d(\text{top form}) = 0$ .

The exterior derivative is odd from the point of view of the exterior algebra:

$$d(\alpha_p \wedge \beta_q) = d\alpha_p \wedge \beta_q + (-1)^p \alpha_p \wedge d\beta_q$$

The exterior derivative is nilpotent:

$$\boxed{d^2 \omega_p = dd\omega_p = 0}$$

This follows from the equality of mixed partial derivatives,

e.g.  $C^\infty(\Lambda^0) \xrightarrow{d} C^\infty(\Lambda^1) \xrightarrow{d} C^\infty(\Lambda^2)$

$$df = \partial_j f dx^j, \quad d^2 f = \partial_i \partial_j f dx^i \wedge dx^j = \frac{1}{2} (\partial_i \partial_j f - \partial_j \partial_i f) dx^i \wedge dx^j \\ = 0$$

This leads to familiar statements in  $\mathbb{R}^3$ :

$$\omega_0 = f(x)$$

$$\omega_1 = V_1(x) dx^1 + V_2(x) dx^2 + V_3(x) dx^3$$

$$\omega_2 = W_1(x) dx^2 \wedge dx^3 - W_2(x) dx^3 \wedge dx^1 + W_3(x) dx^1 \wedge dx^2$$

$$\omega_3 = \phi(x) dx^1 \wedge dx^2 \wedge dx^3 \quad (\text{top form})$$

$d\omega_0 = \partial_i f(x) dx^i$ , the gradient of  $f(x)$

$d\omega_1 = (\epsilon_{ijk} \partial_j V_k(x)) \frac{1}{2} \epsilon_{ilm} dx^l \wedge dx^m$ , curl of  $\vec{V}(x)$

$d\omega_2 = (\partial_1 W_1 + \partial_2 W_2 + \partial_3 W_3) dx^1 \wedge dx^2 \wedge dx^3$ , divergence of  $\vec{W}(x)$

Then  $d^2 \omega_0 = 0$  is  $\vec{\nabla} \times (\vec{\nabla} f(x)) = 0$

and  $d^2 \omega_1 = 0$  is  $\vec{\nabla} \cdot (\vec{\nabla} \times \vec{V}(x)) = 0$

### • Hodge star

Maps  $p$ -forms to  $(n-p)$ -forms (recall  $\dim(\Lambda^p) = \dim(\Lambda^{n-p})$ ):

$$*: C^\infty(\Lambda^p) \rightarrow C^\infty(\Lambda^{n-p})$$

as follows:

$$*(dx^{i_1} \wedge \dots \wedge dx^{i_p}) = \frac{1}{(n-p)!} \epsilon_{i_1 \dots i_n} dx^{i_{p+1}} \wedge \dots \wedge dx^{i_n}$$

[Note: When we introduce a metric, we'll have to be more careful. For now we don't care - we work in flat space  $\mathbb{R}^n$ .]

Hodge-starving twice gives back the same p-form  
up to a sign:

$$**\omega_p = (-1)^{p(n-p)} \omega_p$$

- Adjoint of exterior derivative

$$\delta : C^\infty(\Lambda^p) \rightarrow C^\infty(\Lambda^{p-1})$$

Defined as  $\boxed{\delta = (\star)^{np+n+1} * d *}$

Like  $d$ ,  $\delta$  is also nilpotent:  $\delta^2 \omega_p = \delta \delta \omega_p = 0$ .

We can combine  $d$  and  $\delta$  to define the

Laplacian  $\Delta : C^\infty(\Lambda^p) \rightarrow C^\infty(\Lambda^p)$ , by

$$\boxed{\Delta = (d + \delta)^2 = d\delta + \delta d} .$$

For example on 1-forms

$$\Delta(\vec{V}(x) \cdot d\vec{x}) = - \frac{\partial^2 \vec{V}}{\partial x^k \partial x^l} \cdot d\vec{x}$$

A  $p$ -form satisfying:

- $d\omega_p = 0$  is called a closed form
- $\delta\omega_p = 0$  " " " co-closed form
- $\Delta\omega_p = 0$  " " " harmonic form
- $\omega_p = d\alpha_{p-1}$  " " " an exact form
- $\omega_p = \delta\beta_{p+1}$  " " " a co-exact form

Two theorems:

(1)  $\omega_p$  is harmonic ( $\Leftrightarrow$ )  $\omega_p$  is closed and co-closed

(2) If  $M$  is a compact manifold without boundary,  
any  $p$ -form can be uniquely decomposed as

$$\omega_p = d\alpha_{p-1} + \delta\beta_{p+1} + \gamma_p, \text{ with } \Delta\gamma_p = 0.$$

(Hodge's theorem)
