

Problem 3.

IMA 1013.a) For $x \in \mathbb{R}$,

$$\text{let } f(x) = \int_{-\pi/4}^{\pi/4} \tan^2(u) \, du.$$

$f(x)$ is well defined because $u \mapsto \tan^2(u)$ is continuous (and bounded) on $[-\frac{\pi}{4}, \frac{\pi}{4}]$.

But $f(x)$ is a constant (with respect to x), so directly differentiable,

$$\text{and we have: } \forall x \in \mathbb{R}, f'(x) = 0.$$

3.b) For $x \in \mathbb{R}$, let $g(x) = \int_0^x e^{-t^2} \, dt$

$$\text{and } f(x) = \int_0^{g(x)} \sin(u) \, du$$

$$= \int_0^{\left(\int_0^x e^{-t^2} \, dt\right)} \sin(u) \, du.$$

* $t \mapsto e^{-t^2}$ is continuous on \mathbb{R} and Riemann-integrable on $[0, x]$, so g is well defined, continuous and differentiable on \mathbb{R} .

3.b) (...)

And \sin is continuous and integrable on \mathbb{R} ,
so $x \mapsto \int_0^x \sin(u) du$ is well defined,
and continuous and differentiable on \mathbb{R} .

By composition, $f(x) = h(g(x))$

is also well defined, continuous and
differentiable on \mathbb{R} .

And so, for any $x \in \mathbb{R}$,

$$f'(x) = g'(x) \cdot h'(g(x))$$

thanks to the chain rule

$$\text{i.e. } f'(x) = g'(x) \cdot \sin(g(x))$$

$$\text{But } g'(x) = e^{-x^2}$$

Conclusion.
$$f'(x) = e^{-x^2} \cdot \sin\left(\int_0^x e^{-t^2} dt\right)$$

for any $x \in \mathbb{R}$.

3.c) For $a \in \mathbb{R}$, let $g(u) = \int_0^u \frac{1}{1+v^2} dv$.
 $v \mapsto \frac{1}{1+v^2}$ is of class C^0 on \mathbb{R} (i.e., well defined and continuous),

so $g(u)$ is well defined, continuous and differentiable on \mathbb{R} ,

Remark: In fact: $g'(u) = \left[\arctan(v) \right]_0^u$
 $= \arctan(u)$

(the reciprocal function of \tan)

And now, for $x \in \mathbb{R}$, let $f(x) = \int_0^x g(u) du$.
 g is continuous on \mathbb{R} \Rightarrow Riemann-integrable on $[0, x]$
 $(\text{or } [x, 0], \text{ regarding the sign of } x)$ for any $x \in \mathbb{R}$,
 $\Rightarrow f$ is well defined, continuous and differentiable
 on \mathbb{R} (i.e. f is of class D^1)

And finally, we know that, for $x \in \mathbb{R}$,

$$\begin{aligned} f'(x) &= g(x) & (= \frac{d}{dx}(x) \cdot g(x) - \frac{d}{dx}(0) \cdot g(0)) \\ &= \int_0^x \frac{1}{1+v^2} dv = \underline{\arctan(x)} \end{aligned}$$

B.d') Similarly, for $x \in \mathbb{R}$, $g(x) = e^x$

g is of class C^1 on \mathbb{R} ,

and so if $f(x) = \int_0^{g(x)} \ln(u^2) du$,

f is well defined because for any $t \in \mathbb{R}$,
 $u \mapsto \ln(u^2)$ is well defined and integrable
on $(0, t]$ (or $[t, 0]$..)

f is also continuous and differentiable because
 g is continuous on \mathbb{R} .

Finally, For $x \in \mathbb{R}$,

$$\begin{aligned} f'(x) &= g'(x) \cdot \ln(g(x)^2) \\ &= e^x \ln(e^{2x}) \end{aligned}$$

So $\forall x \in \mathbb{R}, f'(x) = 2x \cdot e^x$
