Next steps TrustPID: As you may have already experienced, on 6 January 2023, Deutsche Telekom AG, Orange SA, Telefónica S.A. and Vodafone Group plc have notified to the European Commission their intention to create a new joint venture, <<https://eur-lex.europa.eu/legal-content/EN/TXT/?uri=CELEX%3A52023M10815&qid=1673945925873>>. As the TrustPID project will thus be raised to a European level and will be transferred from a pilot to a regular operation, it is suggested to enter into an industry dialogue with the new JV at an early stage. If TrustPID will be rolled out at the European level, all other supervisory authorities would be affected in addition to the competent data protection supervisory authority for the new JV to be established. This applies, among other things, to the supervisory authorities responsible for the website operators participating in the procedure, but also in particular to participating telecommunications providers. Against this background, a European dialog with a broad participations of the supervisory authorities is expedient.

Hello,

As discussed, here is what I gathered from the discussion :

- All three DPAs received the letter from DGCOMP. BFDI answered, France and Spain are in the process of answering

- There is some questions related to the LSA for the future joint venture. Probably BE. In any case, there is some ePrivacy and national aspects (the websites themselves) that mean that DPA can still be involved

- We feel that until the project is better defined, the best way forward is to have an active monitoring of the subject, and to involve all DPAs in that monitoring. Indeed, the BEUC request, and the inevitable rollout of the scheme EU-wide justifies that position.

The way forward would be :

- (for France?) To contact TrustPID to ask them to have a meeting followed by a question round, with all DPAs, following the "Privacy Sandbox" model organised by Ireland. The question would then be transcribed to a written document, and TrustPID would be asked to provide written answers. This meeting would take place at the end of February, and last 1:30 to 2 hours.

- To book a 20 minutes timeslot at the next TECH meeting (16th of February), to explain to all DPAs why we are bringing back the subject on a EU level, and encourage them to take part to this meeting. A short infonote should be provided to explain our reasoning (if I understand well BFDI proposed to make a first draft, but I might be wrong).

Does that seem to reflect our conversation? Don't hesitate if that's not the case.

Please excuse our late response to your kind invitation.
As I mentioned during today's TECH meeting, we had a meeting yesterday with representatives from TrustPID, Orange and Telefonica. During the meeting they used a presentation which was a Spanish translation of the one used in France and Germany. The information provided during the meeting is similar to what has already been distributed in Confluence. They also said that the European Commission will contact national data protection authorities to ensure that the information provided is consistent in all Member States. They also informed us that they will start testing the system in Spain next month and that they had made some adjustments to the system following the suggestions provided by our colleagues from Germany.
We will distribute all the documentation provided by TrustPID as soon as we receive the files in English.
We would like to confirm our availability for a trilateral discussion next Wednesday 25 or Thursday 26. We can adapt to any video conferencing system you prefer, or we can provide a virtual room in our Microsoft Teams service.
